Minimum Advertised Price Policy

In an effort to allow all retailers an equitable share of the market, Solar Sun Rings has implemented a Minimum Advertised Price Policy. The primary reason for this change in policy is due to damage sales outlets caused by loss leader advertising on online auction sites and bulletin sites, such as E-Bay and Craigslist.

We, Solar Sun Rings, Inc. are the patents holder, manufacturer, and master distributor for the United States. We sell Solar Sun Rings nationwide on a multi-tiered price schedule that allows all forms of businesses to participate in sales of our products. The online auction sites and bulletin sites in question have given providers the ability to offer goods for sale simply by placing advertising. Competition between these online providers has driven the on line price below the level at which merchants who maintain stores and displays can compete.

This type of price cutting and advertising goods at great discounts has caused damage to retailers in other industries. One of these was Brighton Industries, a women's purse manufacturer, who had a company deeply discount their goods on the internet that affected the sales of retailers having stocked showrooms, displays and trained sales personnel. The Supreme Court ruled that the manufacturer had a right to establish a minimum advertised price to help maintain the store owners who stocked and sold their products. The entire decision is available at the Supreme Court's website under docket # 06/240.

We, at Solar Sun Rings, Inc want to give all forms of business the ability to sell our products profitability. Therefore the following schedule of minimum advertised prices is now established.

Solar Sun Rings and Solar Sun Rings Plain: \$27.95

Solar Sun Rings with Water Anchor and Solar Sun Rings with Water Anchor Plain: \$29.95

Solar Spa Covers: \$74.95

Twister Component with Adaptor \$ 59.95

We at Solar Sun Rings hope all providers will observe this schedule of prices. For those providers who do not abide by these guidelines, we will not warranty any product sold at prices below these levels. All customer claims will be referred to the seller for all warranty adjustments at the providers' expense. If a provider continues to sell at below these levels, a lawful cease and desist order will be issued

Solar Sun Rings Storage Guide

The following are guidelines to storing your Solar Sun Rings for maximum performance and lifespan:

Storage during the swimming season

- Solar Sun Rings may be removed and stacked on a completely shaded area, free from any sunlight throughout the day. Any surface where Solar Sun Rings are placed must be smooth and non abrasive. Placing them over grass, plants, or soil is not recommended.
- If necessary, Solar Sun Rings may be folded into quarters (fold in half once, then fold again). Deflation of the outer ring or the inner grid will not be necessary.
- Solar Sun Rings may also be hung by the attached loop on a non abrasive hook beside a non abrasive surface beneath a completely shaded area. They must also be hung at least 2 inches away from any external heat source such as a light or an outdoor heater. (Loop not available on the Solar Spa Cover.)

Storage during the winter, off season

- If local temperatures remain over 35° Fahrenheit (2° Celsius), then keeping Solar Sun Rings on the pool can be possible, but occasional cleaning of the rings may be necessary. If this method is preferred, deflation of the outer ring or the inner grid will not be necessary. Storing them under a winter cover on the pool is not recommended.
- If local temperatures are less than 35° (2° Celsius), or if storage away from the pool is preferred, then Solar Sun Rings may be stored away for long periods of time. First, deflate the outer ring and the inner grid by inserting the supplied deflation stems in the valves until no air is present, then completely clean, dry, and fold the rings as mentioned above. Place the Solar Sun Rings in a non abrasive and sealed container that will not be deformed or altered over a long period of time. The container may be placed in a cool and dry place such as a storage shed or a garage. Leaving the container outdoors or in an area exposed to the elements must be avoided and is not recommended.
- After storage over a long period of time, the Solar Sun Rings may be opened individually and be inflated according to the Inflation Instructions provided with each ring. Folding creases will relax and fade under sufficient sun exposure within 15 to 30 minutes. Once proper care is maintained and instructions are followed, your Solar Sun Rings will perform as designed, generating heat for your pool.
